New Braunfels Water Conservation and Drought Management Plan Ordinance

Sec. 130-214. Minimum irrigation area and flow direction

Newly installed irrigation systems using pop-up spray or rotor technology shall not be used in landscaped areas which have both:

- 1. Dimensions less than five feet in length and/or width, and impervious pedestrian or vehicular traffic surfaces along two (2) or more perimeters.
2. Where pop-up sprays and rotor heads are allowed in newly installed irrigation systems, they must direct flow away from any adjacent impervious surface and shall not be placed within four inches (4") from an impervious surface.

Sec. 130-215. Rain Sensors.

Rain sensors shall be installed and maintained on all irrigation systems equipped with automatic irrigation controllers.

Sec. 130-2163. Zonal system.

In-ground irrigation systems installed on and after January 1, 2007, shall be zonal irrigation systems.

NBU Water Systems Connection Policy

2.9.2 Water Systems

All small commercial buildings with a site plan of 10,000 sq. feet or less and all single family dwellings are required to have separate irrigation meters if an irrigation system is installed.
